### **BSE / TSE**

**Sugar Spheres** are not made from and does not come in contact with products of human or animal origin. Its starting materials do not come in contact with material of Bovine, Ovine, or Caprine origin during the manufacturing process. Therefore our product is free of any rich forms of Bovine Spongiform Encephalopathy (BSE) and Transmissible Spongiform Encephalopathy (TSE). Our product complies with the requirements of EMEA/410/01 Rev.3.

### **GMO**

Raw materials used in the manufacturing of our product are not stemmed from genetically modified organisms (GMO).

Consequently our Sugar **Spheres** are not subjected to the obligations of GMO labeling and traceability by the application of these requirements 1829/2003 and 1830/2003.

**Lead per California Proposition 65**

Our product is tested for lead on a periodic basis. The detection limit is 0.05 ppm. Results are typically less than the detection limit.

**Residual Solvents and Organic Volatile Impurities**

The raw materials, manufacturing process and product do not contain any of the Class 1, Class 2 or Class 3 solvents listed in Organic Volatile Impurities USP<467> and Residual Solvents Ph. Eur. <5.4> (EMA/CHMP/ICH/82260/2006 and ICHQ3C (R6)). Since there is no potential for these substances to be present, testing is unnecessary.
